TRIALS REPORT

Another great year of trials is now behind us and 2004 is shaping up to be a big one for the sport in this state. I have yet to see a 2004 NSW calendar but can confirm that BWP will be promoting two club days on the 21-3-04 and the 12-9-04; also we have applied for an open date on the 27-6-04. Gandangara have granted approval for use of the Menai venue but keep in mind Key Officials are compulsory for all events.

Pencil in the 15th, 16th and 17th of October 2004 for the Australian MotoTrial Titles at Pacific Park. BWP will be taking a major role both financially and with officials. For this event to be a success a huge effort will be needed from the entire NSW/ACT Trials fraternity. An Open Trial will be held on the Friday to allow competitors who are not eligible for the Championship classes and Officials for the Saturday and Sunday to have a ride and to be part of this great event.

It has been resolved that BWP will no longer hold a Presentation Christmas Party mainly due to the poor attendance and high costs involved in recent years. Keith Greentree will include the Roadrace Championships as part of the RB series and it was suggested the Trials Presentation may be held as part of a BWP (members only) Sunday afternoon social trial in late November or early December.
